WHEREAS in term of section 14(1) of the NCTE Act, 1993 A.Y.T. College of Education, Plot No.287, Vill- Ghataila- Gaji, Post- Piparapati- Via- Deoria, Tehsil- Deoria, District- Deoria-274001, Uttar Pradesh, had applied for grant of recognition for B.T.C. course of Two years duration with an annual intake of 50 (Fifty only) students on 18.10.2007.

AND WHEREAS, the inspection of the above institution was conducted on 12.02.2008. The original file of the institution, VTR along with all other related documents were considered by the committee in its 132nd Meeting held from September 11-14, 2008 and the committee decided to Issue show cause notice. Accordingly, show cause notice was issued to the institution on 23.09.2008.

AND WHEREAS, the matter was considered by the NRC, in its 140th meeting on April 24-26, 2009 and committee decided to refuse the recognition and return FDRs, if submitted. Accordingly, letter was issued to the institution on 04.06.2009.

AND WHEREAS, the above said Institution, thereafter preferred an appeal before the Council (NCTE, New Delhi) under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 03.03.2010 remanded back the case to the NRC for reissue of the show cause notice to the address of the society. The said order was considered by the NRC, in its 157th meeting held from 24th to 27th March, 2010 and decided to re-issued the show cause notice with the direction to the Institute to submit reply within one month. Accordingly, letter was issued to the institution on 13.04.2010.

AND WHEREAS, the matter was considered by the NRC, in its 161st meeting on 26th to 27th May, 2010 and committee decided that VT may be sent to verify deficiencies met. Accordingly, inspection letter was issue to the institution on 04.08.2010.

AND WHEREAS, the NCR has constituted visiting team to visit the institution under section which 14 has visited the institute on 11.08.2010 the original file of the institution, VTR alonwith all other related documents were considered by the committee in its 172nd Meeting held on November 12-13, 2010 and the committee decided that the letter intent prior to grant of recognition under clause of 7(9) was issued to the institution on 08.01.2011.

AND WHEREAS, the reply of the institution dated 14.03.2011 received on 18.03.2011 giving details of the teaching staff appointed by the institution has been considered by the NRC in its 182nd meeting held from 15th to 21st May, 2011 and committee decided that the institution may submitted the details on following points for this regard letter dated 12.07.2011 was issued

 The experience certificate of the Principal, so as to establish that he has the required experience of teaching in a Primary/Elementary Teacher Education Institute.

A copy of the minute of the selection committee that selected Principal/Lecturer.

A signed list of candidates, who appeared before the selection committee.

 A copy of the advertisement in the press in response to which candidates applied for the post of Principal/Lecture.

AND WHEREAS, the reply submitted by the institution in response to the NRC's letter dated 12.07.2011, was considered by NRC in its 185th meeting held from July 26-31, 2011 and NRC decided to issue formal recognition under section 7(11) of the NCTE regulation, 2009 for an intake of 50 (Fifty only) seats to the B.T.C. Course from the year 2011-12.

AND WHEREAS, As per direction received from NCTE Headquarter vide letter F. No. 40-1/2011/CDN/ NCTE/A41349 dated 26.08.2011, the letter on intent under clause 7(9) should have to be issued for the session 2011-12 instead of 2010-11.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants the recognition to A.Y.T. College of Education, Plot No.287, Vill-Ghataila- Gaji, Post- Piparapati- Via- Deoria, Tehsil- Deoria, District- Deoria-274001, Uttar Pradesh for 50 (Fifty Only) seats in B.T.C. Course under clause 7(11) of NCTE Regulation 2009 from the academic session 2011-2012.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- . Land and Building Particulars
- Staff Profile
- · Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993.
